ORDER

Subject: Manufacturers [including Repacker and Relabellers] to upload or link mandatory Lab Testing Report [Six-monthly] on FoSCoS-reg.

Conditions of License number 12 [Annexure-3] of Schedule 2 of FSS (Licensing and Registration) of Food Businesses, 2011 specifies that Food Business Operator shall "Ensure testing of relevant chemical and/or microbiological contaminants in food products in accordance with these regulations as frequently as required on the basis of historical data and risk assessment to ensure production and delivery of safe food through own or NABL accredited /FSSAI notified labs at least once in six months."

- 2. Further, FSSAI has issued clarification on the frequency of the mandatory bi-annual testing of food products vide order No. 15(31)2020/FoSCoS/RCD/FSSAI dated 8th July, 2021. [Order Copy is attached at **Annexure-1**]
- 3. Now, to bring in transparency and to ease out the filing of Annual Returns by the food businesses at the end of the financial year, Food Authority has mandated that all Manufacturers [including Repacker and Relabellers] shall, through FoSCoS, either upload six monthly lab testing reports as per Condition of License number 12 [as per the frequency defined in above mentioned FSSAI order] or link such lab reports from the InFoLNet wherever the samples are analyzed by FSSAI notified labs. A user manual to upload the lab test report /link from InFoLNet is attached at **Annexure-2**. Accordingly, all Manufacturers [including Repacker and Relabellers] are directed to upload/link these lab reports w.e.f FY 2022-23.
- 4. The last date for uploading/linking of the six-monthly lab test report for the period April 2022 to September 2022 is 31st March 2023. Thereafter, FBO shall ensure that uploading /linking of the six-monthly lab test report is done on FoSCoS within one month from the closing date of respective half yearly period i.e by 31st October for the period of April to September and by 30th April for the period of October to March.

ORDER

Subject: Clarification regarding frequency of mandatory product testing under condition of license 12 of FSS (Licensing and Registration of Food Businesses) Regulations, 2011.

As per existing condition of license No. 12 under FSS (Licensing and Registration of Food Businesses) Regulations, 2011:

"Ensure testing of relevant chemical and/or microbiological contaminants in food products in accordance with these regulations as frequently as required on the basis of historical data and risk assessment to ensure production and delivery of safe food through own or NABL accredited /FSSA notified labs at least once in six months."

- 2. In this regard, various representations from the FBOs/Food Industry Associations are being received with the request to clarify whether the said periodicity is to be reckoned on calendar year wise/financial year wise.
- 3. In order to align mandatory product testing with the submission of online Annual Return which is Financial year wise, it is clarified that testing of food products as per the ibid condition of license No. 12 of said regulations shall be carried out by manufacturers on the basis of Financial Year i.e. first half year from April to September and second half year from October to March.

It is further clarified that those food business operators who get their new licenses issued in the last months of respective half-year i.e. in the month of September and March shall be exempted from mandatory testing for that preceding & ending half year period.

Further provided that the gap between two mandatory testing of the same food product shall not be less than 03 months.

4. This issues with the approval of the Competent Authority.





Uploading/Linking of Six-monthly Lab Testing Report by Manufacturers of Food Products (as per condition of license no. 12)


- 1. Login to FoSCoS (https://foscos.fssai.gov.in) through 'Login Businesses' tab on the FoSCoS Homepage.
- 2. Click on "Upload Six Monthly Lab Testing Report" on Left Menu Panel and click on Proceed.




3. After clicking on **Proceed**, you would get following screen.




4. When you click on "Upload Six Monthly Lab Testing Report", you have to select the period from the dropdown for which Lab Testing report is being uploaded/linked.




- 5. List of Products endorsed on your license will be displayed. Select the appropriate product for 'Uploading / Linking of Report'. Below Pop-up window will be opened.
